GENERAL INFORMATION

• FEES: One ticket per class

Pre-Entry: \$6.00 per ticket, \$60.00 all day. **Due: July 15.**

Post-Entry: \$7.00 per ticket, \$70.00 all day.

Arena Fee: \$3.00 per rider.

Stalls: \$15.00 per stall plus \$10.00 refundable stall cleaning deposit (separate checks, please)

- Stay until 5 pm on Sunday and the stall fee will be returned. Clean your stall and your stall cleaning deposit will also be returned.
- Check in times are on Friday, July 17th from 4pm to 6 pm and on Saturday, July 18th from 7 am to 9 am and from 11 am to Noon
- No cross entry in age group. Age as of January 1
- Green horse – First year showing, 4 years & under
- Green rider – First year showing
- Humane training devices allowed in green horse classes only
- Show clothes required
- Horse must be current on vaccinations & able to pass vet inspection
- Refund with doctor or vet excuse only
- Maximum gate hold of 2 minutes to be requested at least one class prior
- Please clean stall prior to leaving
- Classes may be combined, split, or canceled
- Judges' decisions are final
- Stalls assigned according to entry postmarks. Move in can only occur after a Vet Check has been completed.
- Unloading and loading in trailer parking area only. No vehicles of any kind allowed inside gated area until after 5:30 p.m. on Sunday.
