Hours of Operation

Showcase Hours are from 10am -6pm on Wednesday, July 15 and all participants **must be set up the entire time.** Move in is from 7:30 am to 9:30 am. No cars will be allowed on the grounds after 9 am. Fair staff will be available with gaters at 6pm to help participants move items out to their cars. Each participating business or organization will receive a total of 4 day passes for their staff or volunteers. Passes are required for everyone entering the grounds (even during set-up time) unless they qualify for free senior admission

Competing vendors will be allowed to participate. Vendors are encouraged to provide their own unique signage to promote their service.
